



## GRATIS LICENSE

For good and valuable promotional consideration, as described below, the receipt and sufficiency of which is hereby acknowledged by you, the parties hereto agree as follows:

1. The audiovisual work which is subject to this License is entitled “\_\_\_\_\_” (“Film”).
2. The project for which this License is issued is **Home Movie Day compilation DVD** (“Project”).
3. The territory for which this License is issued is the World (“Territory”).
4. Licensor hereby grants to Licensee, its successors and assigns, the non-exclusive, irrevocable right, license, privilege, and authority to a) reproduce and distribute the Film as included in the Project in perpetuity, and in advertising, promotion, and publicity in connection herewith.

5. Licensor warrants that Licensor owns or controls one hundred percent (100%) of the Film and that it has the legal right to grant this License with respect to Licensor's interest in the Film, and that no licenses, permissions, or consents of any kind of any third party are required for Licensor to grant to Licensee the license granted hereunder. Licensor further agrees, represents, and warrants that the Film will be free and clear of any claims by any person or entity and agrees to indemnify Licensee from any claims by any person or entity which are inconsistent with the foregoing warranties and representations.
6. All rights granted hereunder are granted on a non-exclusive basis.
7. In consideration of this License, Licensee shall furnish to Licensor one (1) complete DVD copy of the entire Film, and two (2) DVD copies of the Project. Videotape masters of the Film shall remain the exclusive property of Licensee. No royalties or other payments of any nature shall be payable by Licensee or any of our licensees, distributors, or other designees to Licensor for any use of the Film pursuant to the License granted herein. If any royalties are inadvertently paid (or credited) to you in connection with the exploitation of the Film notwithstanding the foregoing gratis license, you shall pay to us the amount thereof promptly after those royalties are so received or credited.
8. Licensee shall afford the owner of the Film credit in the following form:  
**"Title of film" *provided courtesy of* "Licensor's name,"** unless credit in another form is specified here.

All other characteristics of said credit shall be at Licensee's sole discretion. No casual or inadvertent failure by Licensee or any failure by a third party to comply with the credit requirements of this paragraph shall constitute a breach of this License. Without limiting the generality of the foregoing, in no event shall Licensor be entitled to, and it hereby agrees not to seek, injunctive or other equitable relief for any breach of or non-compliance with the credit provisions set forth in this paragraph.

9. The license set forth herein shall be in lieu of any license required or otherwise contemplated under the United States Copyright Act (or other applicable law) for the uses hereunder.
10. This License is binding upon and shall inure to the benefit of the respective successors, assigns, and/or sublicensees of the parties hereto.
11. The terms set forth in this License constitute the entire agreement between Licensor and Licensee, all prior negotiations and understandings being merged herein.
12. This License sets forth the entire agreement between Licensor and Licensee with respect to the subject matter hereof, and may not be modified or amended except by written agreement executed by the parties hereto. This License shall be governed by and subject to the laws of the state of California, applicable to agreements made and to be wholly performed within such state. Any controversy rising under this License if litigated, shall be adjudicated in a Court of competent jurisdiction within the City of Los Angeles and the County of Los Angeles, CA.
13. No failure by Licensee to perform any of its obligations hereunder shall be deemed a breach hereof unless Licensor has given notice of such failure to Licensee and Licensor does not cure such non-performance within thirty (30) days after receipt of such notice.
14. Licensor's rights and remedies in the event of a breach or an alleged breach of this License will be limited to Licensor's right, if any, to recover damages in an action at law not to exceed the amount of this license, and in no event shall Licensor be entitled by reason of such breach or alleged breach to enjoin, restrain, or seek to enjoin or restrain the distribution or other exploitation of the Project.
